**2. Validity of GTC**

As far as not expressly contrary was agreed upon in writing, our GTC are valid. The GTC are to notify for the contracting party.

**3. Offers**

Our offers are not-binding, if not agreed differently in writing.

**4. Prices**

All prices specified by us in Euro are, if others not noted, exclusive value added tax.

In the case of accounting the legal value added tax will be added where applicable.

Prices are valid for 7 days if not contrary agreed.

**5. Terms of payment**

The purchase price is to be paid in advance or if agreed within 7 days after receipt of the purchase invoice without any deductions. In the event of payment delay we are entitled to charge interests in legal height.

**6. Transport**

Our selling prices contain, if not agreed differently, no costs for delivery, import fees, taxes, assembly or installation.

These achievements are provided by us against separate payment.

## **7. Retention of title**

The commodity remains our property up to the complete payment of the purchase price and all other costs and expenses.

## **8. Warranty/guarantee**

Warranty for business customers for products developed and assembled by Derma Medical Systems 12 month after delivery.

In addition to the legal guarantee of 12 months we grant for final customers and end users a full warranty of 24 months starting from delivery or installation for products developed and assembled by Derma Medical Systems.

This will not embrace third party products like delivered Digital Cameras, Monitors and such similar devices, warranty to claim directly from the producer.

Pre-condition for it is the intended use according to operating instruction as well as no autonomously accomplished changes in hard- and software.

Customers have to notify in writing within 2 weeks about deficiencies of delivered products.

## **9. Compensation**

Apart from personal injuries we liable only if we are proved by the claimant for rough negligence.

It is the customer's obligation to secure his existing data sufficiently.

## **10. Area of jurisdiction**

For all disputes developing from contracts the local court at the seat of our enterprise is responsible.

However we have the right to complain also at the general area of jurisdiction of the contracting party.
